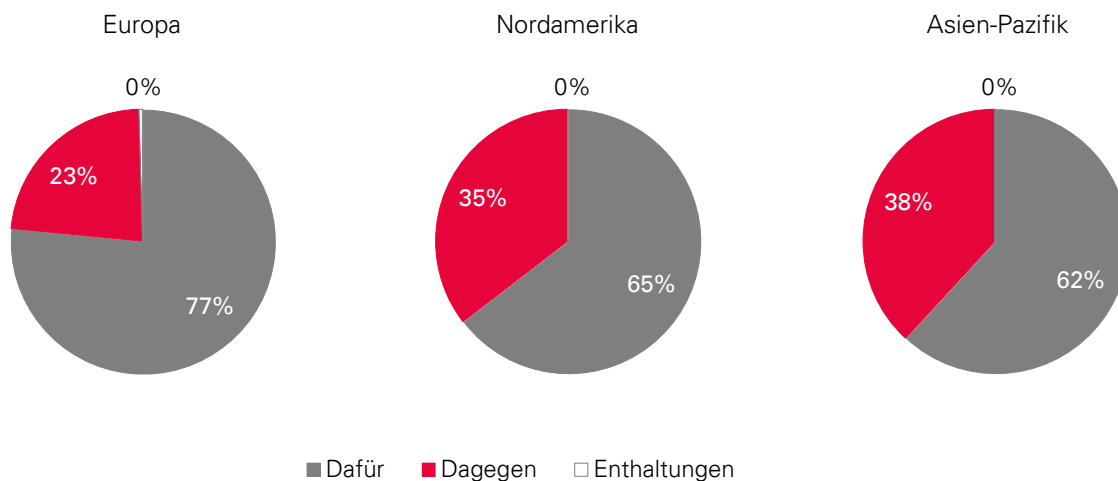
#### Disclaimer

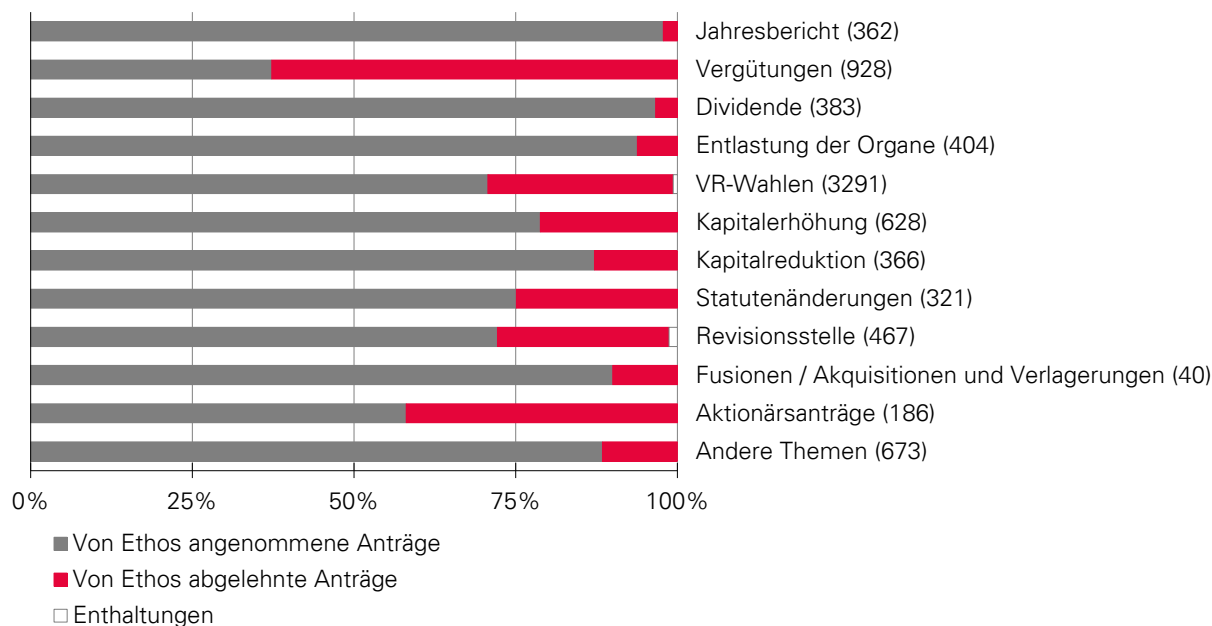
